SERVICES



1. Warehousing

We are staffed by an experienced team, providing a clean and safe environment with due regard to Hazchem legislation and Responsible Care, when required. Goods are received and appropriately stored in a safe, uncontaminated environment consisting of the following services:

- *Warehousing with full sprinkler systems maintained annually*
- *Bonded warehousing available in major regions*
- *24-hour security and alarm on site, with armed response*
- *Modern cloud based stock control systems in place*
- *Cyclical physical stock counts are conducted per requirement*
- *First in, first out principle controlled by batch number*
- *Certificate of analysis issued with deliveries where required*
- *Average 24-hour delivery service, guaranteed within 48 hours for local deliveries with regular updates per request*
- *Products segregated by category and/or product class*
- *Quarantine area to ensure your clients receive quality*
- *Expedient facilities for COD and Calling customers*
- *Warehouse access limited to authorised personnel*
- *Immediate reporting and repair or repackaging of breakages per client requests, which helps limit shrinkage*
- *Expedient management of urgent same day deliveries*
- *Consolidated cargo for transport to major centres*

2. Intercity and Local Distribution

We operate our own fleet of vehicles, ranging from 1-34mt, some with tail lifts. Our vehicles and drivers comply with all specific legislation relating to the transport of various categories of goods including food grade, general cargo, and dangerous chemicals.

All vehicles are equipped with cellular phones and satellite tracking devices which are constantly monitored using the latest tracking software.

Attention is paid to regular replacement & maintenance of all our vehicles, to ensure that no delays are encountered with regards to deliveries. All vehicles have the necessary fire permits for flammable products and department of health certification to carry food related products.

Stobel makes use of cross-docking which streamlines the supply chain thereby reducing handling, warehousing, and storage costs.

2.1 Volumetric calculations

Consignments are charged by actual (gross) weight or volume whichever is the greater. Volumetric weight is calculated as follows:

Length x Width x Height (cm)

4000

2.2 Delivery lead times

Local delivery instructions received before 3pm each day will generally be delivered the following working day and are guaranteed for delivery within 48 hours. National delivery lead times will depend on area of service. This information is available on request.

2.3 Fuel levy

All transport rates are subject to changes in the fuel price, which are subject to change on the first Wednesday of each month (as released by the Department of Minerals and Energy).

2.4 Food Grade

Stobel warehouses have allocated food grade sections which undergo ISO audits by our client's numerous times per annum. Procedures are in place to ensure correct storage and transport of food grade goods are adhered to, with allergen, glass, and food/pharmaceutical handling standard operational procedures in place, just to name a few.

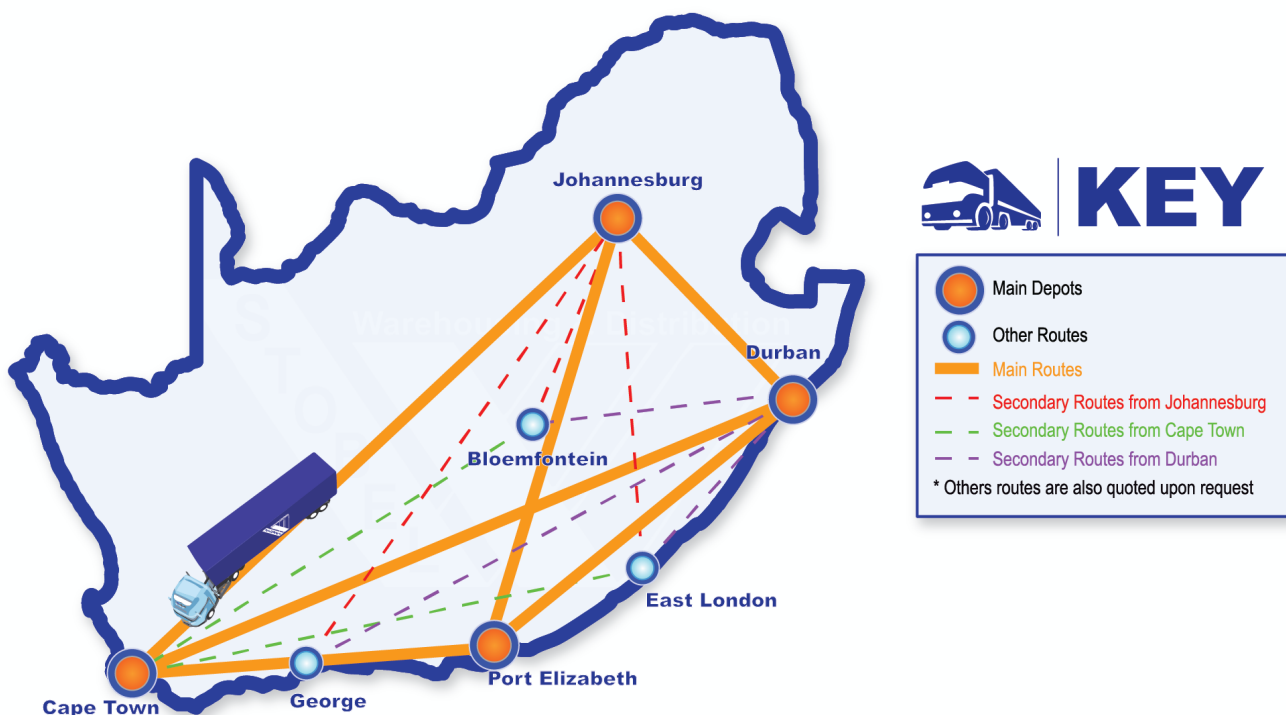
2.4 General Cargo

Although a large portion of Stobel operations are more specialized, we cater for general cargo as well in dedicated sections more suited to block stacking for bulk, racked cargo, and smaller items. Secure and professional transport of general cargo is provided and special requirements are arranged when required.

2.4 Hazardous Chemicals

Many companies dabble in the transportation of chemicals and other hazardous goods, but not many can call themselves specialists.

All our vehicles are equipped with all the necessary safety equipment, driver training & emergency procedures to cope with most incidents. We are also contracted to specialist chemical spill response company's in the event of any untimely incident.

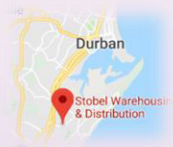

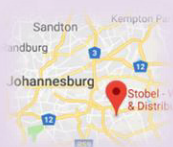
